- Based on the availability of the rooms, Section Enhancement Grant has already been given by CBSE vide letter No: CBSE/130602/IS-04458-2425/2024-25/, dated 06/11/2023
- 2. The height of the boundary wall has been increased to 6 feet.
- The ramps at the entrances of both the blocks have been corrected and made accessible for CWSN students. Ramp has also been planned and work order released for the same. The work is in progress and would be completed in due course.
- 4. Separate CWSN toilets have been both for boys and girls separately.
- Outdoor games –Throw Ball, Volley Ball, Kho-Kho, Kabaddi, Shuttle, Tennikoit, Hand Ball are provided with proper markings giving the needed space.

- 6. In both Biology lab and Physics lab, wooden benches are replaced with wooden stools. The present measurements of the Bio Lab are: 31x19.4ft = 603 sq feet and Physics lab are 31x19.4 ft=603 sq ft, as per the latest norms of the CBSE By-Laws 2018 page No: 13.
- Library has been upgraded and provided with a Teacher Reading area.
- 8. Fresh land certificate as per Appendix -X is obtained. But as the lease deed was on two different dates, two land certificates have been provided with the same number and date, bearing No: 28/2024/C dated 24-01-2024.
- 9. The school has two blocks. As one of the blocks, has only ground floor, as per Fire Safety Standards, mentioned in Indian Standard 14435:1997,"Code of Practice for Fire Safety in educational Institutions" NOC from Fire Department is not required. But for all good reasons, all the class rooms and three labs, which are stationed in the block are provided with fire extinguishers including fire alarm and are kept ready from time to time.
- 10. All the uneven surfaces have been attended and are made easily accessible even to CESN students. The campus is always kept clean and hygienic.
- 11. The school has conducted teacher training in coordination with CoE Vijayawada. The school hosted a two day Two Day offline CBP in the month of July on the topic " Adolescent Education " by Mrs. Vamsipriya Amar and Dr.Reshma Ganesh, from MVJ Bangalore and Pt Ravi Shankar School, East, Bangalore respectively. The training was attended by all the teachers. Apart from this, many on line trainings were attended by teachers on 1. Digital Wellness 2. Digital Technology for Children with Special Needs 3. Social Media and Cyber Security 4. Cyber Safety and Security.

The School hereby declares that we have not taken any admissions into Grade XI for the academic year 2023-24. Admissions would be taken only from 2024-25 batch and Grade XII students would be appearing for board examinations in the year 2025-26.
